## Section 3: Hazards Identification

Eyes:	Causes severe eye irritation.

Spill Procedure:

Remove all sources of ignition. Provide adequate ventilation. Wear appropriate personal protection. Sprinkle absorbent compound onto spill, then sweep into a plastic or metal container. Wipe up further residue with paper towel and place in container. Wash spill area with soap and water.

## Section 7: Handling and Storage

**Handling:** Wash thoroughly after handling. Avoid contact with eyes, skin, and clothing. Do not ingest or inhale. Do not expose container to heat or flame.

**Storage:** Keep away from sources of ignition. Store in a cool, dry, well ventilated area, away from incompatible substances. Keep from freezing.
